

General Secretary's 2024/25 Report

Another year over, an awful lot of same old same old as far as the role goes.

Renewing the insurance, Check! Although as the company we insure with forgot all about our renewal (And several other sporting club renewals!) so we didn't get our certificate until the end of March. They assured me, we were fully insured at all times. I am so glad we didn't have a claim to test that statement. I have already sent them a reminder asking for this year's quote. This amount is based on the number of active branches relying on our insurance as well as the total number of members.

Each year in December I send out a branch information form. Check! By the 1st of February we had replies to this request for details of branch officers and the branch programme from just 15 branches. I have had to chase a further 13 branches for those details Some have responded Unless I receive updates from the other branches by 17th Feb I will assume they do not want the Guild Branch Insurance and renew accordingly. This will possibly save us around £400 unless premiums have substantially increased. Equally well without current and up to date information we cannot maintain the website which is where a lot of branches pick up their members.

Correspondence has been relatively low this year although I have had several requests for help in disposing of deceased member's and ex member's fly tying and fishing equipment. Much of this has been donated to the Guild and indeed some, such as the lan Elder capes have been shared out amongst interested branches this weekend.

We have had several committee meetings both by Zoom and meeting in person and the hosting of these remotely makes life so much easier for all but does take away a bit of the camaraderie which is a bit of a shame.

It is a long time since we increased our membership subscriptions 11 or 12 years I believe. In this period, we have seen the cost of everything increase, our biggest increases being in the cost of printing and posting out Flydresser. We propose to increase rates at this meeting and I would ask all members to remember the substantial benefits you get from the Guild beside Flydresser before cancelling membership for the sake of an extra £5. One purchase of £50 from a trade member offering 10% discount offsets this instantly. If 50% of Guild members encouraged one other person to become a member of the Guild we would possibly not have to increase rates for another 11 years.

On the subject of trade members, I have also managed our relationship with trade members, much of which is done at the BFFI. We continue to offer a good range of discounts as well as receiving other benefits such as raffle and competition prizes. Thank you to all our trade members for their support and generosity. We have added Renomed Scissors to our trade members list and will find out this weekend what they are offering.

A role I fulfil outside of the Secretary's remit is running the Guild Fly Tying Competition. Clearly I'm not very good at this as I haven't won anything since I started doing it. There are two recurring issues with the competition both of which come through members not reading the rules. Of the first 30 entries I received last year only 3 managed to complete the entry

forms correctly. I already know the name of the chosen fly but surprisingly I can't name all 1,000 or so members from their membership numbers alone. Please take a bit more time. The second moan is with entrants not putting their guild membership numbers on the flies. Just the membership number, not name and address (Which should have been on the form) otherwise we can't have an independent and anonymous judging.

Thirdly and this is a plea not a moan, the number of entries is not very high given the membership and the quality of fly tyers out there. Come on, have a go, if nothing else it will improve your own tying.

As I stated in Flydresser this will be my last AGM as Chair as I intend to stand down in February 2026. I will probably not be at that meeting and hope that whoever takes over will receive the same wholehearted support I have had over the past 13 years. I am happy to remain on the committee of the FDG for the foreseeable future and will obviously offer help and advice if needed.

I am pleased that the rest of the committee have taken on their roles with such gusto and the FGD is no longer a one man or even three-man band. Sharing the responsibility makes everyone's life so much easier. Thank you to each and everyone of you.

Treasurer's 2024/25 Report

The Guild suffered and excess of Expenditure over Income of just under £2,000 for the financial year ending 31 August 2024.

Membership, in common with many other angling related organisations, is on a reducing trend and expenses are, inexorably, increasing.

The Guild is in the fortunate position of having significant reserves however the committee is committed to continuing their careful scrutiny of expenses and finding ways to reduce these in the future.

At the same time the committee is examining ways to increase membership by improving and extending our offerings and increasing our exposure to younger audiences and to develop other sources of income including through merchandising and advertising.

The Guild continues to depend on the significant unpaid work of the editorial committee of the Flydresser.

If our efforts to restrict expenditure and increase income are not successful it may be necessary in future years to recommend an increase in subscriptions.
